**Eligibility:**

- All applicants must be members, children of members or grandchildren of members of the Hart-Parr Oliver Collectors Association
- The applicants must be enrolled or accepted for enrollment in an accredited college, university, junior college, trade/technical school, or other similar post-secondary educational institution.
- Applicant must be pursuing a degree in an agricultural related field.

**Requirements:**

**Please read the requirements section carefully.**

1. All applicants are required to answer the 5 questions on the application with a 100 word minimum answer.
2. All applicants must submit an essay of 300-500 words answering the following questions.
  - a. What is an attribute of Charles Hart, Charles Parr or James Oliver that lead to their success.
  - b. How would this attribute apply to you?
  - c. How could your chosen career field/major in agriculture relate to the Hart-Parr/Oliver corporations of today?
3. All applications and essays must be submitted by March 1—postmarked or emailed by that date.
4. Each application must include a photo for printing in the **Hart-Parr Oliver Collector**.
5. Each essay shall include a cover page and bibliography.
6. All essays shall become property of the Hart-Parr Oliver Collectors Association and each applicant consents to the publication of their essay, without compensation, in the official **Hart-Parr Oliver Collector** magazine.

**Selection Process:**

- The National Board of Directors shall appoint a scholarship committee to review all properly submitted essays.
- The committee's decision is final.
- Winning recipients will be notified by April 1.
- Scholarship payment will be paid directly to the educational institution that the applicant identified as required in these guidelines.
- Payment will be made after first completed semester of college.
- Scholarship recipients will be invited to attend the National Summer Show to read their winning essay at the annual banquet.
